OUR INTERVENTIONS

Advocate relevant Government authorities to undertake necessary general measures and implement the United Nations Convention on the Rights of the Child (UNCRC)'s Concluding Observations and Universal Periodic Review (UPR)'s recommendations;

Improve CSOs' capacity to support children and advocate the Government to put in place the mechanisms that work for child rights;

Advocate for inclusion of issues identified by children and CSOs in Social Economic Development Plan (SEDP);

Empower children and their rights to participate in decision making processes;

Improve the awareness of enterprises on Child Rights Business Principles and support for the adoption of these principles in their value chains.
